



Priests and religious brothers credibly accused and/or removed from ministry in the Diocese of Jefferson City

Sept. 11, 2023: changes underlined

Clergy and religious brothers credibly accused and/or removed from ministry in the Diocese of Jefferson City.

This list includes the following:

- Priests of the Diocese of Jefferson City who have been credibly accused of actions in violation of the “Charter for the Protection of Children and Young People,” regardless of when or where those actions reportedly occurred.
- Brothers and priests of religious orders, and priests of other dioceses, who have served in the Diocese of Jefferson and were found by their religious order or dioceses to be credibly accused of actions reportedly occurring in our diocese in violation of the “Charter for the Protection of Children and Young People.”
- Clergy and priests of religious orders who have served in the Diocese of Jefferson City and were found by the diocesan bishop to be unsuitable for ministry out of concern for the safety of our youth.

No Bishop of Jefferson City has been credibly accused or meets the criteria to be listed.

When we are notified by an ecclesiastical superior that a cleric or religious, who at one time served in our diocese, has been found credibly accused of sexual abuse of a minor outside our diocese, the Bishop of Jefferson City informs the parishes where the credibly accused cleric or religious served and invites anyone with further information to contact the Victim Assistance Coordinator. In such a situation, since the report of abuse reportedly occurred outside of the Diocese of Jefferson City, the name of the credibly accused cleric or religious does not appear on our list.
